### GENERAL INFORMATION

#### 16. SERVICE CLASSIFICATION NOS. 13 AND 14 AGREEMENT FOR SMALL CUSTOMER AGGREGATION: (CONT'D)

take Managed Storage Service to be determined solely by the Company, as more fully described in General Information Section 5.I. of PSC No. 88 Gas, or superseding issues thereof.

3. NYSEG will advise the Customer or its designated agent how much gas it is to deliver to NYSEG. NYSEG will then transport gas to Customer sufficient to meet Customer's requirements on NYSEG's distribution system or to meet NYSEG's storage injection schedule, in accordance with the applicable tariff, PSC No. 88 Gas, or superseding issues thereof, Service Classification No. 13 for residential customers and Service Classification No. 14 for non-residential customers.

4. Customer shall be entitled to change designated agents only between April 1 and April 30 of each year and only upon thirty (30) days prior by written notice to NYSEG. Customer is entitled to return to NYSEG sales service on fifteen (15) days notice if NYSEG has the ability to provide the service. There is no absolute guarantee that Customer can return to NYSEG sales service. Customer may change designated agents outside of the April 1-30 period only in emergency situations. NYSEG shall have the right, at its sole discretion, to determine if such emergency exists.

5. In the event Customer returns to firm sales service, or changes designated agents during the April 1-30 election period or in other emergencies, NYSEG will recall the upstream interstate pipeline capacity and any Managed Storage Service, and if necessary, will reassign the capacity, on Customer's behalf, to another designated agent selected by the Customer.

#### B. Service Pursuant to Tariffs

This service and the prices shall, in all respects, be provided in accordance with the terms and conditions of PSC No. 88 Gas, or superseding issues thereof, Service Classification Nos. 13 and 14 and all other applicable tariffs. The Company shall have the right to propose, file and make effective with the Public Service Commission of the State of New York or any other governmental body having jurisdiction, revisions to any applicable service classification for the purpose of changing the prices, charges, and other provisions thereof effective as to the Customer. This Agreement is subject to all valid existing and future laws, rules, regulations and orders of all governmental authorities, (federal, state and local) having jurisdiction over the parties hereto or the subject matter hereof. NYSEG's duties shall be contingent upon the receipt and continuance of any necessary regulatory authorizations.
