TC-2.0	Customers with a maximum annual capability of burning between 25,000 and 55,000 Mcf:	\$0.9300 per Mcf
TC-3.0	Customers with a maximum annual capability of burning between 55,000 and 150,000 Mcf:	\$0.6234 per Mcf
TC-4.0	Industrial Customers with a maximum annual capability of burning greater than 150,000 Mcf:	\$0.2937 per Mcf
TC-4.1	Non-Industrial Customers with a maximum annual capability of burning greater than 150,000 Mcf:	\$0.3863 per Mcf
