For Service Classification No. 5 Firm

Customer takes full responsibility and assumes all liability including, but not limited to, contingent liability for its decision to execute this certificate and opt not to pay the Demand Cost Adjustment rate.

For firm transportation service the Customer _____ (agrees or does not agree) to retain the right to return to a "sales customer" and to pay the Demand Cost Adjustment rate in accordance with Special Provision B.2 of Service Classification No. 5.

Customers not electing to pay the Demand Cost Adjustment rate and customers electing Pooled Aggregation under Service Classification No. 11 will be required to have installed and operable an Approved Remote Meter as defined in Rule 13.5.

For Service Classification No. 7 Firm

For firm transportation service, the Customer _____ (agrees or does not agree) to retain the right to return to a "Sales Customer" and to pay the Demand Cost Adjustment rate in accordance with Special Provision A.4 of Service Classification No. 7

If the Customer chooses "does not agree", the Customer certifies that all of the operations for which Low-Volume Gas Transportation service is taken under Service Classification No. 7 of the Niagara Mohawk Power Corporation (Company) P.S.C. No. 218 Gas Tariff have existing dual fuel capability in full working order.

Upon execution of this certification, Customer will have the option of paying to the Company the Demand Cost Adjustment rate, as described in Service Classification No. 7. Customers not certifying dual fuel capability must pay the Demand Cost Adjustment rate.
