SERVICE CLASSIFICATION No. 7
Interruptible Transportation Service (Continued)
(Rate Codes: 710, 711, 720, 721)

Rate (per meter, per month):

The rate per therm for the four service categories below, shall be established at the discretion of the Company, but is not to exceed the firm transportation service margin for Service Classification No. 3 or be lower than \$0.01 per therm. The Customer may elect to take service at the monthly variable rate, based on the applicable rate for this Service Classification for the current month or take service for twelve (12) months at the fixed rate based on the average of projected monthly interruptible margins over a twelve (12) month period. The rate per therm for each of the four service categories will be published in the Statement of Rates and Charges for Interruptible Service. These categories are defined as follows:

- (Rate Code 710) - Category A : Customers who are exempt from the Petroleum Business Tax and whose annual thermal energy requirements are less than 100,000 dth;
- (Rate Code 711) - Category C : Customers who are not exempt from the Petroleum Business Tax and whose annual thermal energy requirements are less than 55,000 dth;
- (Rate Code 720) - Category B : Customers who are exempt from the Petroleum Business Tax and whose annual thermal energy requirements are equal to or greater than 100,000 dth; and
- (Rate Code 721) - Category D : Customers who are not exempt from the Petroleum Business Tax and whose annual thermal energy requirements are equal to or greater than 55,000 dth.

Supplemental Service:

A Customer shall pay the applicable Service Classification No. 4 rate for the gas used during the billing period that exceeded the gas delivered at the Receipt Point during the billing period for the customer's account adjusted for fuel use and losses.

Heating Value Adjustment:

The volume of gas registered by the customer's meter, in CCF, will be converted to therms as explained in Rule II.3G.

Increase in Rates and Charges:

The rates and charges set forth in this Service Classification including Minimum Charges are increased by the applicable percentage as explained in Section III.2 for service supplied within the municipality where the customer is taking service.

Terms of Payment:

The Customer shall pay the balance due in cash or its equivalent on receiving the bill, or be subject to late payment charge in accordance with provisions of Rule II.3E.2.
