- b. Rate per month for Customers that meet the qualifications under the General Service Classification No. 3:

2. Miscellaneous Surcharges

- a. Reliability Capacity Charge

The rates in this Service Classification shall be increased by the Reliability Capacity Charge ("RCC"). The RCC shall recover the purchased gas demand costs associated with the capacity the Company must retain in order to ensure system reliability. The RCC shall be established monthly (and filed with the Company's monthly GAC statement). Such purchased gas costs collected through the RCC shall be included as revenues for the recovery of purchased gas costs as specified in the General Information Section 19.f.(1).

- b. Utility Low Income Energy Efficiency Program (ULIEEP) Surcharge

The rates in this Service Classification shall be increased by the ULIEEP surcharge, as described in General Information Section II.39.

- c. Take or Pay Recovery

Transportation rates shall be subject to a surcharge per 100 cu.ft. as set forth in General Information. Section II.38.

- d. Increase in Rates in Municipality Where Service is Supplied

All rates and charges under this Service Classification, including charges specified under the Special Provisions of this Service Classification and the Transportation Service Agreement, shall be increased pursuant to General Information Section II.35, to reflect the tax rates applicable within the municipality where the Customer is taking service.

- e. Transition Costs Associated with F.E.R.C. Order No. 636.

The rates for service rendered pursuant to the Service Classification shall be subject to a monthly transition cost surcharge as described in General Information Sections II.19.j. and k.

- f. Weather Normalization Adjustment

SC 21 rates shall be subject to a refund/surcharge as set forth in General Information Section II.36.
