Commencing June 1, 1995, the monthly Effective Rate per therm for all Customers for the first year will be capped at 10 percent above the net revenue maximization model used prior to June 1, 1995. For the second and third years, the increase will be limited to no more than an additional 10 percent each year.

Statement of Rate:

The Effective Rate per therm as well as the Maximum and Minimum Price calculations will be shown on the Statement of Rates and Charges for Interruptible Service filed with the Public Service Commission as explained in Rule III.3A.

Heating Value Adjustment:

The volume of gas registered by the customer's meter, in 100 Cu. Ft., will be converted to therms as explained in Rule II.3G.

Increase in Rates and Charges:

The rates and charges under this service classification including the Minimum Charges are increased by the applicable percentage as explained in Rule III.2 for service supplied within the municipality where the customer is taking service.

Minimum Charge:

The Minimum Charge is \$1,580.40 per meter per year, exclusive of Increase in Rates and Charges. This Minimum Charge is not applicable to Customers taking Supplemental Service under this classification.

Terms of Payment:

The Customer shall pay the balance due in cash or its equivalent on receiving the bill, or be subject to late payment charge in accordance with provisions of Rule II.3E.2.
