## CHARACTER OF SERVICE:

Standby service shall permit the Customer to purchase deficiency imbalance gas from the Company on a firm basis, comparable to the quality of service provided to the Company's firm bundled service customers, subject to the curtailment steps. Service under this Rate Schedule shall be available only if the Company projects that sufficient volumes of gas will be available to the Company during the period of the contract to provide the level of service desired by the Customer, without jeopardizing the reliability of service to the Company's existing Customers receiving firm gas service.

## MONTHLY RATES:

1. Monthly Standby Demand Charge

The default Monthly Standby Demand Charge ("SB-DC") rate per Mcf contracted in the Standby Service Agreement shall be as listed below:
