##### (2) Cove Point LNG Surcharge:

The charges incurred from Consolidated System LNG Company in Docket CP83-75; et al. for the Cove Point LNG facility will be recovered by means of a charge to the service classifications indicated below in the Combined Area.

- (a) Customers taking transportation service under Schedule PSC No. 88 Gas, or superseding issued thereof:

For Service Classification Nos. 1, 4 and 5 customers in the Combined Area subject to PSC No. 88 Gas, or superseding issues thereof, the surcharge shall be \$0.00755 per Therm.

##### (3) Transition Cost Surcharge (TCS):

- (a) The following adjustments shall reflect a surcharge calculated pursuant to Opinion 94-26, issued and effective December 20, 1994, in Case 93-G-0932, and the PSC's August 11, 1995 and March 28, 1996 Orders in Cases 93-G-0932 and 95-G-1041:

- (i) The PSA applicable to Service Classification Nos. 1, 4, 5, 13 and 14 of PSC No. 88 Gas, or superseding issues thereof.

- (b) The purpose of the TCS is to recover transition costs billed to the Company by interstate pipelines pursuant to Federal Energy Regulatory Commission (FERC) Order No. 636. The TCS shall be recovered in the following manner:
