TERM:

The term shall be as specified in the Service Agreement.

GENERAL TERMS AND CONDITIONS OF SERVICE:

To the extent not inconsistent with the provisions of this service classification, service hereunder is provided in accordance with the General Information Sections of this Schedule.

SPECIAL PROVISIONS:

- A. The quantity to be billed under this service classification is the metered quantity.
- B. Metering and Balancing Provisions for Daily Metered Customers Customers installing electronic telemetering shall be subject to daily balancing and will be reconciled as set forth in General Information Section 4 of this Schedule. The city-gate balancing tolerance shall be plus or minus two percent (2%).
- C. Metering and Balancing Provisions for Non-Daily Metered Customers Each month the Company shall direct non-daily metered aggregated pool operators to deliver the estimated average daily quantity of gas necessary to meet the daily requirements of the pool for the month. Such quantity may be revised during the month as required to match pool consumption. Such revision will be effective twenty-four (24) hours following an Aggregation Nomination Order (ANO) and until such time as the Company changes or rescinds the ANO. Aggregated pools without daily recording meters who do not take Managed Storage Service or are not eligible shall pay a balancing surcharge as reflected on the Gas Transportation Rate (GTR) Statement. The city-gate balancing tolerance shall be plus or minus two percent (2%). Customers taking Managed Storage Service shall pay a Managed Storage Service charge as set forth on the Gas Transportation Rate (GTR) Statement.
- D. Firm Transportation Service will be provided on a "first call" basis for the available capacity in the Company's distribution system. If other applicants desire Firm Transportation Service and there is only available capacity for the "first" applicant, the "first" applicant can reserve the required available capacity for a period of three (3) months. If deliveries are not commenced within the three-month period, the available capacity will be released for the use of the other applicants.
