## THIRTY DAY MINIMUM CHARGE:

The thirty day minimum charge is \$20.00 for all customers served under this service classification, exclusive of the Commodity Cost Adjustment charges. In addition to the minimum charge, customers may be required to pay a surcharge when service is taken from a main extension constructed in accordance with Rule 10, General Information.

## COMMODITY COST ADJUSTMENT CLAUSE:

Residential and commercial heating, as well as industrial customers, will be able to apply for a Fixed Commodity Cost Adjustment Clause (FCCAC) or retain the current variable Commodity Cost Adjustment Clause (CCAC). For residential and commercial non-heating customers the CCAC will apply. The FCCAC will be effective December 1, 1997, and remain in effect through April 30, 1998 and will be limited to 10 percent of customers by class. The charges set forth herein shall be subject to either 1) a CCAC or 2) a FCCAC per therm of gas supplied hereunder when changes from the base cost occur as explained in Rule 17 of this schedule. Customers that do not elect the FCCAC will automatically be charged the CCAC.

# BTU ADJUSTMENT:

Volumes of gas registered at the customer's meter, in CCF, will be adjusted for BTU content, in Therms, as stated in Rule 14.3.
