# Rider H - VOLUNTARY CLEAN ENERGY PROGRAM - Continued

### D. Eligibility

To receive service hereunder, a Customer must meet the following eligibility requirements:

- 1. The Customer must take service pursuant to one of the Service Classifications eligible under this Rider.
- 2. The Customer must submit an application to the Company identifying the maximum annual amount, on a \$/Mlb basis, it would pay for one or more Qualifying GHG Reduction Measures and such other information as the Company deems necessary.
- 3. The Customer agrees to meet financial security requirements deemed necessary by the Company.

The Company will review the Customer's application for the purpose of confirming eligibility for service under this Rider. If the Company, in its sole discretion, determines that the supply of Qualifying GHG Reduction Measures is limited, participants may be selected on a first-come, first-served basis, based upon the date and time of receipt of the Customer's completed application, through pro-rata allocations among participating Customers or other non-discriminatory means determined appropriate by the Company.

The Company shall be under no obligation to pursue or implement a Qualifying GHG Reduction Measure if the Company determines that: (1) a Qualifying GHG Reduction Measure is unavailable; or (2) the pursuit or implementation of a Qualifying GHG Reduction Measure would compromise the reliability of the steam system, present unreasonable operational challenges, or unduly burden non-participating Customers.

### E. Qualifying GHG Reduction Measure Agreement

The Company and a Customer determined by the Company to be eligible for service under this Rider shall negotiate and execute a written Qualifying GHG Reduction Measure Agreement prior to the commencement of service hereunder. The disposition of applicable emissions reduction credits will be set forth in the written agreement and shall be negotiated by the Company and the Customer.
