## Gas Cost Adjustment:

The charges set forth herein for Gas Interconnection, Gas Transportation, Gas Supply and Load Balancing shall be charged through a gas cost adjustment per therm supplied hereunder as set forth in 2.XII.

# Minimum Charge:

For sales service \$710.00 and Transportation Service \$710.00 per meter, per month, plus applicable revenue taxes.

<u>Contract Administration Charge</u>: For transportation customers a charge of \$125.00 per account, per month, plus applicable revenue taxes shall be billed to individual customers

## Monthly Minimum Bill:

The Monthly minimum bill shall be the Demand Charge applied to the Contract Volume, the Contract Administration Charge, the Minimum Charge and all applicable revenue taxes.

#### Annual Minimum Consumption Charge:

For Sales Service: the positive difference obtained by subtracting the volume taken by customer in the contract year from 365,000 therms billed at the combined sales rate of all services offered under Sales Service plus applicable revenue taxes.

For Transportation Service: the positive difference obtained by subtracting the quantity taken by customer in the contract year from 365,000 therms billed at the combined transportation rate of Distribution Delivery (First 12 times Contract Volume), Gas Interconnection and Load Balancing (if contracted for) plus applicable revenue taxes.

For Transportation Service delivered to Empress, Alberta, Canada: the positive difference obtained by subtracting the volume taken by customer in the contract year from 365,000 therms billed at the combined transportation rate of Distribution Delivery (First 12 times Contract Volume), Gas Interconnection, Load Balancing (if contracted for), and Gas Transportation plus applicable revenue taxes.
