9. RIDER - GREEN GAS RENEWABLE NATURAL GAS ("RNG") RIDER

The Green Gas Renewable Natural Gas (RNG) program incorporates a renewable energy source into its supply portfolio and offers firm customers the option of purchasing Green Gas RNG. This rider is available to all firm customers presently being served under Service Classification Nos. 1A, 1B, 1BDG, 2, 3, 15, 16, and 17. This rider offers residential customers an opportunity to participate in the program by paying a flat monthly charge that will help to offset the premium cost for this renewable product. This rider offers non-residential customers two options to participate in the program: 1) by paying a flat monthly charge that will help to offset the premium cost for this renewable product or 2) electing a percentage of their monthly bill that will be allocated to Green Gas RNG and will be charged a Green Gas RNG weighted average cost of gas to that allocation.

Green Gas RNG Rider for Customers Served Under Service Classification Nos. 1A, 1B, and 1B-DG:

A customer served under SC 1A, 1B, or 1B-DG can elect to have a flat fixed monthly adder to their bill. Flat fixed adder options are: \$5, \$20, \$25, and \$50

Any residential customer electing this option must commit to a twelve-month agreement under this rider.

Green RNG Rider Adder for Customers Served Under Service Classification Nos. 2, 3, 15, 16, and 17

A customer served under SC 2, 3, 15, 16, and 17 will have two options. Option 1:

A customer served under SC 2, 3, 15, 16, and 17 can elect to have a flat fixed monthly adder to their bill. Flat fixed adder options are: \$25, \$50, \$100, \$200 and \$500

Option 2:

A customer served under SC 2, 3, 15, 16, and 17 can elect a percentage of Green Gas RNG to their monthly consumption.
