SERVICE CLASSIFICATION NO. 16
INTERRUPTIBLE TRANSPORTATION SERVICE

APPLICABLE TO THE USE OF SERVICE FOR:

Interruptible Transportation Service to existing sales service customers taking service under this Schedule, or superseding issues thereof, or new customers. Any customer taking service hereunder must qualify for service under Service Classification No. 15 - Interruptible Sales Service.

CHARACTER OF SERVICE:

Transportation of Customer-owned, pipeline quality, natural gas shall be on an interruptible basis from a receipt point within the Company's service territory to which this Schedule applies to the facilities at the Customer's existing delivery point. The Company shall control the dispatch of such gas, and dispatch shall be provided as requested by the Customer, in accordance with General Information Rule 10 of this Schedule, provided, however, that acceptance of the Customer's application shall be conditioned upon the availability of the Company's system capacity.

PRICE: (Per Month)

The price per Therm for usage in excess of 1,000 units shall be determined monthly at the sole discretion of the Company. The price per Therm, over the term of the service, shall be:

- A. Not less than \$.00100 plus the applicable revenue taxes; and,
- B. Not more than the following tables, adjusted by the applicable surcharges and taxes.

The price shall be applicable to transportation customers who contract for transportation service. The price may be revised monthly.
