7.13 AT&T All In One

Effective October 31, 2020, AT&T All In One Local Exchange Service will no longer be available for purchase by new or existing customers. The Company will no longer accept orders for adds, moves, changes, and existing service agreements will not be renewed. Following the expiration of a customer's existing service agreement, service will be provided on a month-to-month basis, at the then current month-to-month rates, until the service is discontinued. During any month-to-month service period, the Company may change the rates, term, and conditions of the service upon notification. Effective October 31, 2021, the Company will discontinue AT&T All In One Local Exchange Service.

7.13.1 Rating of Calls:

The following calling plans are available for AT&T Local Exchange Service All In One customers: Plan A Flat Rate*, Plan B Flat Rate**, Plan C Measured Rate**, Plan E Measured Rate, Plan K Flat Rate, AT&T All In One Advantage Plan and AT&T All In One Advantage Term Plan. Plan A Flat Rate, Plan B Flat Rate, Plan K Flat Rate, AT&T All In One Advantage Plan and AT&T All In One Advantage Term Plan will include the customer's local calling in the monthly recurring line charge. Plans C and E Measured Rate calls will be billed in full minute increments. Fractional minutes will be rounded up to the next full minute increment.

- * AT&T All In One Rate Plan A is not available either under this tariff or through any AT&T Contract Tariff or contract referencing this tariff to new customers who did not have it on order before March 3, 2003.
