#### 7. Service Classification Riders (Available on Request) - Continued

##### RIDER B AGREEMENT AND PREPAYMENT, AS MAY BE REQUIRED, FOR INSTALLATION OF SERVICE LINE AND FURNISHING OF SERVICE EQUIPMENT (Applicable to Service Classification Nos. 1, 2, 3, 4 and 6)

This agreement covers the furnishing, installing and connecting of a service line and the furnishing of service equipment, as set forth under General Rule 3.2.2, or any part of such installation, as determined by the Company is required to serve the Customer's premises. The Customer hereby agrees to pay to the Company, before the work is begun, the sum of \$\_\_\_\_\_ to cover the Company's estimated cost in excess of the estimated five-year revenue from the Customer. The estimated revenue is based on the Load Letter submitted by a Professional Engineer on \_\_\_\_\_. Estimated revenue is the estimate of the Pure Base Revenue from the Customer for service from such service line and service equipment. The prepayment amount may be revised and the Agreement amended if the Customer subsequently makes a material change in its requirements (e.g., a revised service point of entry, service commencement date, or Load Letter signed by a Professional Engineer) that affects estimated revenue or the Company's estimated construction cost.

If the Customer made a prepayment, it will be repaid to the Customer in monthly installments, without interest, until the earlier of its complete refund or ten years from the date when service is first supplied. Each monthly installment will be equal to one-tenth of the total amount of each bill for steam supplied to the Customer and, if applicable, one-tenth of the total amount of each bill for steam supplied to other new Customers connected to such service line. The unrefunded prepayment, if any, remaining at the expiration of the said ten-year period or at the end of a lesser period in the event that the use of steam is permanently discontinued at the Customer's premises will be retained by the Company. The service line, meters, and service equipment furnished by the Company, as specified in the Company's Rate Schedule, shall remain the property of the Company.

As described in General Rule 3.2.2, the Customer may retroactively be required to make a payment, subject to the provisions described above, if the Company determines subsequent to installing and connecting a service line and furnishing service equipment that the Customer did not provide sufficient revenue within five years of the installation to justify the expenditure.
