Effective January 1, 2010, lost revenues will not be recovered for Service Classification Nos. 1B, 1BR, 1BI, 1B-DG, 17-CTS-1B, 17-CTS-1BR, 17-CTS-1BI.

The Company will calculate the SBC by dividing the annual energy efficiency dollars, plus (minus) any over or under-collections from prior years, including carrying charges, by the projected volumes from the following firm service classifications: 1A, 1AR, 1B, 1BR, 1BI, 1B-DG, 2-1, 2-2, 3, 4A, 4B, 7, 17-CTS 1A, 17-CTS 1AR, 17-CTS 1B, 17-CTS 1BR, 17-CTS 1BI, 17-CTS-1B-DG, 17-CTS 2-1, 17-CTS 2-2, 17-CTS 3, 17-CTS 4A, 17-CTS 4B, and 17-CTS 7.
