14. Revenue Decoupling Mechanism ("RDM") Adjustment – Continued

Any RDM adjustment billed to customers as part of the reconciliation adjustment applicable to Rate Years beginning prior to January 1, 2014 will be applied to the same RDM groups as specified in the Gas Rate Plan in Case 09-G-0795.

If the Company does not file for new base delivery rates to be effective within 15 days after the end of Rate Year 3, the RDM will be implemented in accordance with the Gas Rate Plan adopted by the Commission in its February 21, 2014 Order in Case 13-G-0031.

15. Curtailment Cost Recovery Charge applicable to Firm Service Classification Nos. 1, 2, 3, 9 and 13

Firm sales and transportation Customers shall be subject to a charge, stated on a cents per therm basis and shown separately on the Statement of Monthly Rate Adjustment, to recover the costs associated with payments made to ESCOs and Direct Customers in accordance with General Information Section 14(E) "Gas Service Curtailments" of the Schedule.

16. System Benefits Charge ("SBC")

The System Benefits Charge is applicable to Firm Sales and Transportation Customers with the exception of SC-14, Natural Gas Vehicle Service Customers. In 2015, the System Benefits Charge collected amounts directed by the Commission in its Order issued October 25, 2011 in Case 07-M-0548 plus an amount to reconcile prior period over- or under-collections. Starting January 1, 2016, the System Benefits Charge will collect amounts authorized by the Commission for the following: (1) NYSERDA-administered programs and (2) Company-administered energy efficiency programs approved in Case 15-M-0252 that are not recovered in base rates ("Energy Efficiency Tracker"). The applicable unit charges for NYSERDA-administered programs and the Energy Efficiency Tracker will be separately set forth on the Statement of System Benefits Charge. The Statement will be filed with the Commission no less than three business days before its effective date.

The unit charge for the Energy Efficiency Tracker will include a reconciliation for amounts required to be collected prior to 2016. Any over- or under-collection of amounts required to be collected for each calendar year starting 2016 will be reflected in the subsequent year's amount to be collected for NYSERDA-administered programs and/or the Energy Efficiency Tracker, as applicable. Any over- or under-collections after the final collection year will also be reconciled and credited to or collected from Firm Customers.
