(b) Customer-specific information, consisting of Customer name, mailing address, telephone number, account number, and primary language, if available, and any alternate billing name, address, and phone number, for use by the CCA Administrator to execute a CCA opt-out process. Aggregated customer data will not be provided for any service classification having either too few Customers or a single Customer comprising a large portion of the load, which could provide significant information about an individual Customer's usage.

Initial fees for CCA Data Services requested by a CCA Administrator are payable are as follows:

- (a) \$0.30 per account for gas CCA Data Services, payable by the CCA Administrator after the Public Service Commission's approval of the CCA Implementation Plan, Data Protection Plan, and certification of local authorization, provided that the CCA Administrator has entered into a Data Security Agreement with the Company; and
- (b) \$2.70 per account for gas CCA Data Services, payable by the CCA Administrator or the Marketer after demonstrating that the Marketer has entered into a contract with the municipality to provide gas supply to CCA participants.

There will be an additional fee of \$1.50 per account for gas CCA Data Services, payable by the CCA Administrator or Marketer, as applicable, for any request beyond the CCA Administrator's initial request.
