GAS SUPPLY CHARGE

The charges set forth herein shall be subject to a Gas Supply Charge as explained in General Information, Section 27.

MERCHANT FUNCTION CHARGE, SYSTEM BENEFITS CHARGE, GAS BILL CREDIT, NEW YORK STATE ASSESSMENT AND REVENUE DECOUPLING MECHANISM

The charges set forth herein shall be subject to the Merchant Function Charge, System Benefits Charge, Gas Bill Credit, New York State Assessment and Revenue Decoupling Mechanism as explained in General Information Section 42.

WEATHER NORMALIZATION

The charges set forth herein may be subject to a Weather Normalization Adjustment as explained in General Information, Section 27.

INCREASE IN RATES AND CHARGES

The rates and charges under this service classification, including Gas Supply Charge, Merchant Function Charge, System Benefits Charge, Gas Bill Credit, New York State Assessment, Weather Normalization Adjustment, Revenue Decoupling Mechanism Adjustment and minimum charge, are increased pursuant to General Information, Section 28 to reflect the tax rates applicable within the municipality where the customer takes service.

MINIMUM CHARGE

\$46.00 per month, plus applicable Gas Supply Charge, Merchant Function Charge, System Benefits Charge, Gas Bill Credit and New York State Assessment.

TERMS OF PAYMENT

Bills are due when personally served or three days after mailing. Bills shall be subject to a late payment charge in accordance with General Information, Section 16, if payment is not made by the date specified on the bill which date shall be not less than 20 days from the due date.

TERM

Terminable at any time provided that customer cannot resume service within one month at the same location without paying charges during the intervening period in accordance with this classification.

Customers electing service under this service classification may not transfer to interruptible service classifications, for one full year.
