#### 59. TEMPORARY DEFERRAL RECOVERY SURCHARGE/CREDIT

59.1 Pursuant to the Order of the Public Service Commission ("Commission") dated March 15, 2013 in Case No.12-E-0201, the Company was directed to establish a credit/surcharge for its deferral accounts. The surcharges/credits below, by service classification, establish factors for PSC No. 220 and PSC No. 214 and are effective April 1, 2014 through March 31, 2015.
