New York State Electric & Gas Corporation (“NYSEG”) and Rochester Gas and Electric Corporation (“RG&E”) (together the “Companies”) hereby transmit for filing the enclosed tariff leaves in compliance with the New York State Public Service Commission’s (“Commission”) Notice of Tariff Filings Due to Amendment of the Public Service Law, issued November 30, 2018 (the “Notice”), in the above-referenced proceeding. These tariff leaves are transmitted for filing in compliance as identified herein and in accordance with the requirements of Appendix 7-H (electronic tariff filing system) to the Commission’s Codes, Rules and Regulations (16 NYCRR Appendix 7-H).

**Purpose of Filing**

The Companies are filing tariff amendments in compliance with the Notice that requires utilities to review its tariff in consideration of amendments to Public Service Law Section 39.4.

Overview

Section 39.4 of Public Service Law was amended to require utilities to notify customers of their right to an actual meter reading upon discontinuance of utility service. The law further provides that when a residential customer makes a request for an actual meter reading upon discontinuance of utility service, the gas or electric company is required to provide a meter reading within forty-eight hours of the submitted request, unless circumstances beyond control of the Companies make an actual reading of the meter extremely difficult<sup>1</sup>.


Newspaper Publication

The Companies request that the requirements of Section 66(12)(b) of the Public Service Law and 16 NYCRR Section 720-8 as to newspaper publication be waived as the affected customers will be notified of their right to an actual meter reading upon discontinuance of utility service.
