Re: Statement of Value of Distributed Energy Resources Cost Recovery

Dear Secretary Burgess:

Consolidated Edison Company of New York, Inc. ("Con Edison" or the "Company") is filing a revision to the Statement of Value of Distributed Energy Resources ("VDER") Cost Recovery to P.S.C. No. 10 – Electricity ("Electric Tariff") as follows:

VDER-CR – Statement No. 2 to P.S.C. No. 10 - Electricity

This Statement has an effective date of December 1, 2018.

The Statement is issued pursuant to General Rule 26.8 of the Electric Tariff. It contains per-kWh and per-kW charges applicable to all customers to recover credits paid to customers served under the Value Stack Tariff under Rider R of the Electric Tariff.

In addition, Statement No. 2 reflects the following changes:

• The description of the statement was changed to indicate the charges are applicable to all billings under each Service Classification (SC), excluding SC 11, pursuant to General Rule 26.8. This is consistent with the Public Service Commission's September 14, 2017 Order on Phase One Value of Distributed Energy Resources Implementation Proposals, Cost Mitigation Issues, and Related Matters in Case Nos. 15-E-0751 and 15-E-0082, (the "September Order"). Previous language based on the September Order<sup>2</sup> stated that recovery of value stack credits was applicable to supply and/or delivery customers by service classification taking service under the Value Stack provision pursuant to Rider R of the Electric Tariff.

- In compliance with Appendix B of the September Order, the Environmental Out-of-Market value for the demand-billed classes will be recovered through a per kWh charge rather than on a per kW basis.
- Charges for SC 12 Energy Only have been added as this group of customers was unintentionally omitted from Statement No. 1.
- A footnote has been added stating that the Environmental Component Market Value will be included with the Clean Energy Supply Surcharge.

The amount of VDER Credits provided to customers is less than \$30,000, <sup>3</sup> which is recoverable from customers taking service under the Electric Tariff ("Con Edison Customers") and the Power Authority of the State of New York ("PASNY") class. Con Edison Customers and PASNY have been allocated their shares of these charges based on the PASNY Allocation, as defined in Additional Delivery Charges and Adjustments – Section H of the Company's Schedule for PASNY Delivery Service, P.S.C No. 12 – Electricity. At the levels to be recovered as of November 2018, the rates applicable to Con Edison Customers round to zero. Therefore, the share attributable to Con Edison Customers will be recovered in the following year's surcharges effective December 1, 2019.
