Effective February 9, 2018

The above Statements are being filed pursuant to the Company's tariffs, General Information Section 6 of P.S.C. No. 120 and General Information Section 3 of P.S.C. No. 121 for electric service. This filing removes the Village of Cherry Creek from the list of villages shown on the Tax Surcharge Percentage Statement that impose the 1% tax on utility revenues. NYSEG received notice that the Village dissolved and the Company should no longer be collecting this tax.
