Case No. 14-M-0224 – Proceeding on Motion of the Commission to Enable
Community Choice Aggregation Programs**

Dear Secretary Burgess:

National Fuel Gas Distribution Corporation (“Distribution” or the “Company”) submits the following amendment to its tariff, P.S.C. No. 8 - GAS:

Supplement No. 62

Proposed Supplement No. 62, in compliance with Ordering Clause 1 of *Order Establishing Community Choice Data Access Fees*, issued and effective on December 14, 2017 (“CCA Fee Order”) in Case Nos. 17-M-0315, 16-M-0411 and 14-M-0224, is issued as of today on not less than one day’s notice and has an effective date of December 20, 2017. As directed in Ordering Clause 4 of the CCA Fee Order, the requirements of Section 66(12)(b) of the Public Service Law and 16 NYCRR Section 720-8.1 that newspaper publication are waived.

On August 5, 2016, Distribution submitted a proposed tariff amendment in compliance with Ordering Clause 4 of Order Authorizing Framework for Community Choice Aggregation Opt-Out Program, issued and effective on April 21, 2016 in the above referenced case. On October 19, 2016, Distribution filed P.S.C. No. 8 – GAS Supplement No. 54 to postpone the effective date of the tariff amendment to March 1, 2017. On January 11, 2017, Distribution filed P.S.C. No. 8 – GAS Supplement No. 55 to further postpone the effective date of the tariff amendment to March 1, 2017. On March 13, 2017, Distribution filed P.S.C. No. 8 – GAS Supplement No. 57 to further postpone the effective date of the tariff amendment to May 1, 2017. On May 10, 2017, Distribution filed P.S.C. No. 8 – GAS Supplement No. 59 to further postpone the effective date of the tariff amendment to December 1, 2017. On October 24, 2017, Distribution filed P.S.C. No. 8 – GAS Supplement No. 61 to further postpone the effective date of the tariff amendment to March 1, 2018.

Each postponement request was at the request of Department of Public Service Staff ("Staff") for the purpose of providing more time for Staff review. Orders were issued approving those supplements on November 2, 2016, January 18, 2017, March 22, 2017, May 19, 2017 and on November 7, 2017.

The instant filing proposes to cancel Distribution's tariff supplements P.S.C. No. 8 – GAS Supplement No. 57, P.S.C. No. 8 – GAS Supplement No. 59 and P.S.C. No. 8 – GAS Supplement No. 61. Distribution's P.S.C. No. 8 – GAS Supplement No. 54 and P.S.C. No. 8 – GAS Supplement No. 55 were previously cancelled as a result of Distribution's April 21, 2017 filing of Cancellation Supplement P.S.C. No. 8 – GAS Supplement No. 58 in Case No. 16-G-0257- Proceeding on Motion of the Commission as to the Rates, Charges, Rules and Regulations of National Fuel Gas Distribution Corp. for Gas Service.
