**Purpose of the Filing**

The Companies are filing new addenda in compliance with Ordering Clause No. 1 of the Order.

The new addenda, Uniform Business Practices for Distributed Energy Resources (“UBP-DER”), will apply to all Distributed Energy Resource (“DER”) suppliers that participate in Commission-authorized and or utility-operated programs, or markets where transactions occur between DER suppliers and distribution customers.

Within the UPB-DER, there are specific requirements that will apply to Community Distributed Generation (“CDG”) and on-site mass market distributed generation providers.

In accordance with Ordering Clause No. 6, requirements for newspaper publication pursuant to Section 66(12)(b) of the Public Service Law for the tariff revisions is waived.
