The purpose of this filing is to discontinue several of the Company's voice services throughout the Rochester, New York metropolitan area. Level 3 Telecom filed an application with the Federal Communications Commission (FCC) on April 19, 2017 to discontinue the voice services and notified their affected customers of the discontinued service by letter, via U.S. mail, on April 19, 2017. A copy of the Application filed with the FCC and customer notice is enclosed. The following services are being discontinued: Analog PBX Trunk Service, Basic Business Line Service, Business Terminals Service, Centrex Service, Digital PBX Trunk Service, Direct Inward Dial (DID) Service, Integrated LAN (ILAN) Service, Primary Rate ISDN (PRI) Service, VersiPak® IPRI Service, VersiPak® Line and Trunks Service, VersiPak® Mach 2 and VersiPak® Mach 3 Service and VersiPak® Service Packages-VersiPak® Flex T Service and VersiPak® Power T Service.
