Dear Secretary Burgess:

Please find attached for filing revisions to the Village of Hamilton Municipal Utilities Commission (the “Village”) PSC No. 1 – Gas Tariff. The revisions are being made to comply with amendments to the Pipeline and Hazardous Materials Safety Administration’s 49 Code of Federal Regulations Part 19, and after consultation with Department of Public Service Staff. Specifically, the change allows for a customer to request that installation of excess flow valves (“EFV”) on existing service lines where EFVs are not otherwise required at the customer’s expense.

Pursuant to 16 NYCRR § 720-8.1(a)(3), the Village respectfully requests that the Commission waive its newspaper publication requirements for the attached tariff revisions. The Village is not revising any rates or charges. Rather, the Village is implementing these changes in response to an amendment to federal regulations.

VIII. INSPECTION, MAINTENANCE AND REPLACEMENT OF FACILITIES: (Cont'd.)

C. If an act or omission of any customer who had installed facilities necessitates the replacement or reconstruction of such facilities, the customer shall pay to the Utilities Commission the cost of replacement, ~~or~~ reconstruction, or addition.

D. Right to Inspect:

i. A duly authorized officer or agent of the Utilities Commission may enter, at all reasonable times, any building or other location supplied with service by the Utilities Commission for the inspection and examination of meters, pipe, fittings, and works for supplying or regulating the supply of gas and of ascertaining the quantity of gas supplied, provided such agent exhibits a photo-identification badge and written authority as provided in Section 65(9) of the Public Service Law.

ii. Penalty:

a. A customer who, at any time, directly or indirectly prevents or hinders a duly authorized officer or agent of the Utilities Commission from entering the building or location, or from making an inspection or examination, at any reasonable time, may be billed a \$100 penalty charge for each such offense as provided in Section 65 (9) (b) of the Public Service Law.

b. The Utilities Commission may terminate gas service to a customer who fails to pay the Section VIII(D)(ii)(a) \$100 penalty.

c. The Utilities Commission may terminate gas service to a customer who pays the Section VIII(D)(ii)(a) \$100 penalty but nonetheless refuses access to perform inspections after (a) 15 days' notice to the customer, using Form F, and (b) with notice to the Department of Public Service.

E. Special Services on Customer's Premises at a Charge

i. Whenever at the Customer's request, the Company is to relocate or add equipment or facilities to suit the convenience of the Customer, the Customer shall reimburse the Company the entire cost incurred by the Company.
