Dear Secretary Burgess:

The enclosed tariff leaves issued by New York State Electric & Gas Corporation ("NYSEG") and Rochester Gas and Electric Corporation ("RG&E"), (together the "Companies"), are transmitted for filing in compliance with the New York Public Service Commission ("PSC" or "Commission") Order Approving Tariff Amendments (the "Order"), issued and effective April 20, 2017, and Appendix 7-H (electronic tariff filing system) to the Commission's Codes, Rules and Regulations (16NYCRR Appendix 7-H).

A list of the revised tariff leaves is provided as Appendix A. The tariff leaves will become effective on May 1, 2017.

Reason for Proposed Revisions

In accordance with the Order, the Companies are filing "housekeeping" revisions to NYSEG's and RG&E's tariffs to correct the revision numbers to tariff leaves that were previously pending. In addition to the revision numbers, leaves were updated to incorporate tariff filing amendments that were submitted in Case Nos. 14-E-0151, 14-E-0422, 15-E-0302, 15-E-0082 and 15-E-0751 after the original housekeeping filing was transmitted on February 28, 2017.

The Companies request waiver of publication of these proposed changes in accordance with Section 66(12)(b) of the Public Service Law and 16 NYCRR Section 720-8.1, as these "housekeeping" revisions have no direct impact on the Companies' customers.
