Reason for Filing

On December 1, 2016, the Company submitted draft tariff amendments in compliance with the order issued May 23, 2016 in the above case effectuating dynamic load management program tariff changes for the 2017 capability period on or before December 1, 2016. The Order directed the Company to file, with an effective date of May 1, 2017, on not less than one day's notice, the draft tariffs as tariff amendments with the changes required in the body of the Order.

The Order did not direct the Company to make any changes to its draft tariff amendments. This filing is made in accordance with Ordering Clause No. 1 of the Order.

Attachment 1 included with this filing indicate where the revisions have been made to the above leaves which is identical to the draft tariffs filed on December 1, 2016.

In accordance with Ordering Clause No. 4, the requirements of Public Service Law §66(12)(b) and 16NYCRR §720.8.1 as to newspaper publication for the tariff amendments directed by this Order are waived.
