Re: Case No. 16-G-0257 – Tariff Compliance Filing

<u>Proceeding on Motion of the Commission as to the Rates, Charges, Rules and</u> Regulations of National Fuel Gas Distribution Corp. for Gas Service

Dear Secretary Burgess:

In compliance with Ordering Clause 3 of *Order Establishing Rates for Gas Service*, issued and effective on April 20, 2017 ("Rate Order") in the above referenced case, National Fuel Gas Distribution Corporation ("Distribution" or the "Company") submits revised tariff leaves for its tariff, P.S.C. No. 9-GAS. The tariff leaves submitted in the instant filing, set forth in Attachment A, are issued as of today on not less than one day's notice and have an effective date of May 1, 2017.

This is the fourth and last of several filings the Company anticipates in order to effectuate the provisions adopted by the Rate Order. The changes, all to the General Information Section of the tariff, primarily adjust the rates and allocation factors initially filed on April 28, 2016 to comply with the provisions of the Rate Order. Rate design workpapers and rate calculations will be emailed to Department of Public Service Staff. Billing Statements that are effective May 1, 2017 will be filed separately. Changes to General Information Section 47 - Conservation Incentive Program ("CIP") Cost Recovery Mechanism reflect regulatory changes and provisions in the Company's currently effective tariff, P.S.C. No. 8 – GAS, approved subsequent to the initial tariff filing of P.S.C. No. 9 – GAS on April 28, 2016. Other submitted tariff leaves are non-substantive changes to the information lines in the header at the top of each page that indicate basic information about each page. Finally, the instant filing includes a replacement for Section 0 – Leaf 144 (Revision 2 Superseding Revision 0) submitted in the Company's April 26, 2017 Compliance filing.

Consistent with Ordering Clause 6 of the Rate Order, the requirements of Section 66(12)(b) of the Public Service Law and 16 NYCRR Section 720-8.1 that newspaper publication be completed prior to the effective date of the proposed supplement is waived for the instant filing. Notice of the rate changes effectuated by the four filings this week to implement the Rate Order will be filed with the Commission, not later than six weeks following the amendments' effective date, to provide proof that a notice to the public of the changes made by the amendments has been published once a week for four successive weeks in newspapers having general circulation in the areas affected by the amendments.
