Case 16-E-0616 – Order Approving Addition of LED Street Lighting Options with Modifications

Dear Secretary Burgess:

In compliance with the Commission's Order Directing Tariff Revision in Case 16-E-0616 issued and effective March 10, 2017, Central Hudson Gas & Electric Corporation ("Central Hudson" or "the Company") hereby files the following tariff amendments to become effective on April 1, 2017.

Background

On October 27, 2016 the Company filed tariff revisions to include certain provisions under Rate A (Company owned and maintained) of Service Classification ("SC") No. 8 – Public Street and Highway Lighting to reflect the transition from LED fixtures with a listed correlation color temperature ("CCT") configuration of 4000 Kelvin ("K") to 3000 K, address barriers to mass replacement of non-LED with LED, as well as propose the extension of LED options to Service Classification No. 5 – Area Lighting Service. On December 13, 2016, a postponement was filed in response to Staff's request for additional time to complete their analysis. On January 24, 2017 an additional filing was made to include additional fixtures, with various wattage, to allow for wattage and LED efficiencies for LED Rate A (Company owned and maintained) of Service Classification No. 8 – Public Street and Highway Lighting and Service Classification No. 5- Area Lighting Service.

On March 10, 2017 the Commission approved the Company's tariff amendments filed on October 27, 2016, with modifications, but rejected the additional fixtures that the Company proposed in the January 24, 2017 filing. The tariff amendments filed herein, and pursuant to Ordering Clause 1, incorporate these modifications and also include the previously approved 4000 K LED fixture rates, pursuant to page 8 of the aforementioned Order. These modifications are set to become effective April 1, 2017.

Pursuant to Ordering Clause 3, the requirements of Public Service Law §66(12)(b) and 16 NYCRR §720-8.1 as to newspaper publication with respect to the tariff filings listed in the Appendix and the amendments directed in Ordering Clause 1 are waived.
