On March 27, 2017 the Company submitted tariff amendments in compliance with the Commission's Order on Net Energy Metering Transition, Phase One of Value of Distributed Energy Resources, in Case 15-E-0751et al., to become effective on April 1, 2017. On March 31, 2017, a postponement was filed in response to Staff's request for additional time to review the proposed tariff amendments with a new effective date of April 27, 2017.

After further review and discussion with Staff, the Company hereby submits the above amended tariff leaves to become effective April 27, 2017. These leaves will supersede the revisions that were originally filed on March 27, 2017.
