RE: Case 17-E-0238 – Proceeding on Motion of the Commission as to the Rates, Charges, Rules and Regulations of Niagara Mohawk Power Corporation d/b/a National Grid for Electric Service.

Dear Secretary Burgess:

In accordance with the *Order Adopting Terms of Joint Proposal and Establishing Electric and Gas Rate Plans* (issued and effective March 15, 2018) in Cases 17-E-0238 and 17-G-0239 (the "Order"), Niagara Mohawk Power Corporation d/b/a National Grid (the "Company") submits for filing the electric tariff leaves listed on Attachment A. Specifically, Ordering Clause No. 3 directed the Company to file, on not less than one day's notice, tariff revisions necessary to effectuate the provisions adopted by the Order to take effect on a temporary basis on April 1, 2018.

The requirements of §66 (12) of the Public Service Law and 16 NYCRR 270.70 that newspaper publication be completed before the effective dates of the amendments were waived with respect to the rate year one tariff revisions. The Company, however, is directed to file with the Commission, within six weeks of the effective date of the amendments, proof that notice to the public of the changes proposed in the amendments and their effective date has been published once a week for four successive weeks in a newspaper having circulation in each county containing an area affected by the amendments. The requirements of Public Service Law §66 (12) of the Public Service Law and 16 NYCRR 270.70 are not waived in respect to Rate Year 2 and Rate Year 3.

This filing is made in accordance with Appendix 7-H (electronic filing system) to the Commission's Codes, Rules and Regulations (16 NYCRR, Appendix 7-H). As required by the Order, the Active Parties to Case 17-E-0238 have been copied on this filing via electronic mail.
