The purpose of this filing is to apply new banking rules to Community Distributed Generation including provisions for:

- The return of a subscriber's banked credits to the CDG Host after a final bill or subscription cancellation;
- The ability of CDG Hosts to re-allocate banked credits including the Market Transition Credit or Community Credit to any project subscriber including non-mass market subscribers that would otherwise be ineligible to receive such credits;
- Clarification that cost recovery of the Market Transition Credit would be applied on a per-kW basis should a demand-billed class receive such Value Stack compensation through the redistribution of a bank returned to a CDG Host;
- Clarification that all provisions of the CDG program relating to banked credits shall be extended to Net Crediting projects;
- Monthly allocation of a CDG Host's bank; and,
