**RE: Case 21-E-0168 – Tariff Filing by Niagara Mohawk Power Corporation d/b/a National Grid to Amend Its Electric Tariff Schedule, P.S.C. No. 220, to Recover Potential Renewable Energy Certificate Costs from Customers by Modifying the Calculation of the Clean Energy Standard Supply Surcharge.**

The following tariff amendments, issued by Niagara Mohawk Power Corporation d/b/a National Grid (the “Company”), are being transmitted in compliance with the June 21, 2021 *Order Approving Tariff Amendments with Modifications* issued by the New York State Public Service Commission (“Commission”) in the above case number (“Order”):

Ninth Revised Leaf No. 229.3  
Fifth Revised Leaf No. 229.4  
Original Leaf No. 229.5

To P.S.C. No. 220 – Electricity

Effective: July 1, 2021

Ordering Clause No. 1 of the Order directed the Company to file tariff amendments on no less than three days’ notice to become effective on July 1, 2021. As discussed in the body of the Order, the Company’s proposed revisions to Rule 46.3.5.1, Rule 46.3.5.5, and Rule 46.4 were approved. Also discussed in the body of the Order, the Company was directed to file a further revision to its tariff. This further revision should specify that the Company may file updated CESS charges prior to the end of the annual period if the Commission approves additional RES and ZEC costs that the Company was not able to forecast at the time of the annual filing. This revision was added in the form of Rule 46.3.5.6 to Leaf 229.4. Please note that this revision necessitated the creation of Tariff Leaf No. 229.5. Attachment 1 contains the Company’s redlined tariff leaves showing where the changes have occurred. Please advise the undersigned of any action taken regarding this filing.
