RE: Case 15-E-0751, In the Matter of the Value of Distributed Energy Resources and Case 14-E-0151, Petition of Hudson Valley Clean Energy, Inc. for an Increase to the Net Metering Minimum Limitation at Central Hudson Gas & Electric Corporation.

Dear Secretary Phillips:

Consolidated Edison Company of New York, Inc. (the "Company") is filing with the Public Service Commission (the "Commission") amendments to its Schedule for Electricity Service, P.S.C. No. 10 – Electricity (the "Electric Tariff"), applicable to its customers in the City of New York and the County of Westchester. The Company is also filing amendments to its Schedule for PASNY Delivery Service, P.S.C. No. 12 – Electricity (the "PASNY Tariff"),¹ applicable to delivery by the Company of power and associated energy to Authority Public Customers under the PASNY Tariff. The revised Electric Tariff and PASNY Tariff leaves, which are identified below, are filed to become effective on May 1, 2021.

¹ This schedule is also titled, "Delivery Service Rate Schedule Implementing and Part of the Service Agreement Between the Power Authority of the State of New York ("PASNY" or "NYPA") and Consolidated Edison Company of New York, Inc. (the "Company"), dated March 10, 1989, for the Delivery by the Company of Power and Associated Energy to Authority Public Customers."

Reason for Filing

This filing is made pursuant to the Commission's Order Modifying Separate Site Requirements, issued and effective April 15, 2021, in Case 15-E-0751 and Case 14-E-0151 (the "Order"). The Order directed each utility to file tariff amendments modifying the separate site requirement, such that it may be satisfied through other means than a separate deed.

Tariff Changes

Pursuant to the Order, the Company has modified the following sections of the Electric Tariff and the PASNY Tariff as described below.

- Net Metering and Value Stack Tariff for Customer-Generators Applicability section of Rider R in the Electric Tariff and the Applicability section of the Value Stack for PASNY Customer-Generators in the PASNY Tariff have been amended to state the following:
 - The kW of facilities with generating equipment located near each other will be aggregated to determine if the kW limit is met unless each facility meets all of the following criteria: (a) each project up to the respective generating size limit must be separately metered and separately interconnected to the Company's grid; (b) each project must be located on a separate site which can be accomplished by a project having a separate deed or a unique Section-Block-Lot (SBL) or Borough-Block-Lot (BBL) number, a separate lease, and a separate metes and bounds description recorded via either a deed or separate memorandum of lease uniquely identifying each project; and (c) each project must operate independently of the other units.

Conclusion and Notice

As directed by Ordering Clause 1 of the Order, the tariff amendment is filed on not less than ten days' notice, to become effective on May 1, 2021. As specified in Ordering Clause 2 of the Order, the Commission has waived the requirements for newspaper publication.
