Purpose of the Filing

On December 12, 2019, the Commission issued an Order Adopting Changes to the Retail Access Energy Market and Establishing Further Process ("December 2019 Order") with proposed Uniform Business Practices ("UBP") revisions in the above-referenced proceedings (the "Retail Access Proceedings"). On September 18, 2020, the Commission issued an Order on Rehearing, Reconsideration, and Providing Clarification ("September 2020 Order") in the Retail Access Proceedings. Ordering Paragraph 5 of the September 2020 Order approved revisions to Sections 1, 2, and 5 of the UBP.

There were various extensions regarding Ordering Paragraph 5 filed by the parties. On February 10, 2021, the Joint Utilities (Central Hudson Gas & Electric Corporation, Consolidated Edison Company of New York, Inc., KeySpan Gas East Corp. d/b/a National Grid, National Fuel Gas Distribution Corporation, New York State Electric & Gas Corporation, Niagara Mohawk Power Corporation, Orange and Rockland Utilities, Inc., Rochester Gas and Electric Corporation, The Brooklyn Union Gas Company d/b/a National Grid NY) filed a request for an extension to file the UBP revisions on not less than one day's notice to become effective April 16, 2021. The Commission granted this request on February 12, 2021.
