This electronic filing for the Broadwing Communications, LLC PSC Tariff No. 5 discontinues some of the Company's voice services in New York. The following voice and data services are discontinued Basic Line Service, Basic Trunk Service, DID Trunk Service, Digital Trunk Service, ISDN Primary Rate Interface, Digital DID Service, Virtual Exchange Service, Integrated Voice and Data Service, Message Toll Service, Toll-Free Service, IntraLATA Calling Service and associated miscellaneous services. A list of pages included in this filing appear on attachment A, following.

The Company filed a 214 application on January 24, 2020 with the Federal Communications Commission (FCC) and notified affected business customers of the discontinued services by letter via U.S. mail on January 22, 2020. The Company filed a partial discontinuance notice and exit plan on February 5, 2020 with the New York Public Service Commission, Matter No. 20- 00335. A copy of the customer notice was provided to the New York Public Service Commission with the partial discontinuance notice and exit plan under Matter No. 20-00335.
