**RE: Case 17-E-0238 – Proceeding on Motion of the Commission as to the Rates, Charges, Rules and Regulations of Niagara Mohawk Power Corporation d/b/a/ National Grid for Electric Service**

Dear Secretary Phillips:

Consistent with the New York State Public Service Commission's ("Commission") "*Order Adopting Terms of Joint Proposal and Establishing Electric and Gas Rate Plans*" issued on March 15, 2018 in Cases 17-E-0238 and 17-G-0239 ("March 15 Order") and other applicable Commission rules and regulations, Niagara Mohawk Power Corporation d/b/a National Grid (the "Company") hereby submits revised tariff leaves for PSC No. 214 Schedule for Electric Service – Outdoor Lighting, listed in Appendix A hereto, to become effective on a temporary basis on April 1, 2021.

Following discussions with Department of Public Service Staff, the Company submits this filing to implement the Rate Year 3 rates approved in the March 15 Order, replacing compressed Rate Year 3 rates that were filed July 1, 2020 in compliance with the Commission's "*Order Further Postponing Approved Electric and Gas Delivery Rate Increases and Updated Reduction to the Low-Income Discount Credits*" issued May 29, 2020 in the above-referenced proceeding.

On October 8, 2020, the Company filed a petition in Case 17-E-0238 to establish Rate Year 4 delivery rates for all PSC No. 214 service classifications to become effective on April 1, 2021, which is awaiting Commission approval. Once approved, the Company will file revised tariff leaves to reflect any necessary changes to implement proposed Rate Year 4 rates.

This filing is made in accordance with Appendix 7-H (electronic filing system) to the Commission's regulations (16 NYCRR, Appendix 7-H).
