RE: Case 17-E-0238 – Proceeding on Motion of the Commission as to the Rates, Charges, Rules and Regulations of Niagara Mohawk Power Corporation d/b/a/ National Grid for Electric Service

Dear Secretary Phillips:

Consistent with the New York State Public Service Commission's ("Commission") "*Order Adopting Terms of Joint Proposal and Establishing Electric and Gas Rate Plans*" issued on March 15, 2018 in Cases 17-E-0238 and 17-G-0239 ("March 15 Order") and other applicable Commission rules and regulations, Niagara Mohawk Power Corporation d/b/a National Grid (the "Company") hereby submits one copy of the revised tariff leaves listed in Appendix A to its Schedule for Electric Service, PSC No. 220 to become effective on a temporary basis on April 1, 2021. The purpose of the filing is to implement the Rate Year 4 (April 1, 2021 to March 31, 2022) rates in accordance with the March 15 Order, until superseded by rates adopted pursuant to the pending rate case under Case 20-E-0380.

On October 8, 2020, the Company filed a petition in Case 17-E-0238 to establish Rate Year 4 delivery rates for service classifications SC1 VTOU and SC7. The petition also included Rate Year 4 rates for EZR and EJP, all to become effective on April 1, 2021. In the event of a Commission order on the petition between February 26, 2021 and April 1, 2021, the Company will file tariff updates to reflect any necessary changes.

This filing is made in accordance with Appendix 7-H (electronic filing system) to the Commission's regulations (16 NYCRR, Appendix 7-H).

Also, as required by Public Service Law § 66-12 and 16 NYCRR § 720-8.1, the changes set forth in the revised tariff leaves for Rate Year 4 will be published in newspapers in the Company's service territory. The Company will file proof of publication with the Commission once all publications have been made.
