## Dear Secretary Phillips:

In accordance with the *Order Adopting Terms of Joint Proposal and Establishing Electric and Gas Rate Plans* ("Order 1"), issued and effective March 15, 2018 and the *Order Addressing Petition and Directing Tariff Modifications* ("Order 2"), issued and effective June 17, 2019 in Cases 17-E-0238 and 17-G-0239, Niagara Mohawk Power Corporation d/b/a National Grid (the "Company") submits for filing the electric tariff leaves listed on Attachment A. Specifically, Ordering Clause No. 6 in Order 1, which directed the Company to file further tariff changes as are necessary to effectuate the rate year three rates as approved and provided for in the Order. These further tariff changes were directed to be filed on not less than 30 days' notice to be effective on a temporary basis on April 1, 2020. Ordering Clause No. 3 in Order 2, directs the Company to file tariff amendments to implement the authorized rate changes for Rate Year 3 as identified in the body of the Order.

As per Ordering Clause No. 7 of Order 1, the requirements of §66(12) of the Public Service Law and 16NYCRR 270.70 as to newspaper publication of these changes will be published once a week for four successive weeks in newspapers having circulation in each county containing an area affected by these amendments.

This filing is being made in accordance with Appendix 7-H (electronic filing system) to the Commission's Codes, Rules and Regulations (16 NYCRR, Appendix 7-H).
