**Purpose of Filing**

The Companies are submitting tariff revisions in compliance with Ordering Clause No. 11 of the Order.

Overview

The Order directs the utilities to develop a surcharge mechanism to be administered to all non-System Benefits Charge paying customers for a period of one year, beginning January 1, 2020, and file tariff revisions necessary to enable the surcharge.

The Companies have filed revisions to implement the Direct Current Fast Charging (“DCFC”) Surcharge to collect funds for the DCFC Incentive program. The surcharge was developed by dividing the total program costs, as provided in Appendix A of the Order, by the total annual delivery kWh for each of the Companies.

The surcharge will be applicable to customers that participate in Recharge NY (“RNY”) Program and any negotiated agreements that exempted customers from paying the System Benefits Charge.

Newspaper Publication

In accordance with Ordering Clause No. 13 of the Order, newspaper publication in accordance with Public Service Law 66(12)(b) and 16 NYCRR 720-8.1 is waived.
