Dear Secretary Burgess:

Niagara Mohawk Power Corporation d/b/a National Grid (the “Company”) is filing with the New York State Public Service Commission (“Commission”) the following proposed revisions to its Schedule for Electric Service, P.S.C. No. 220 – Electricity (the “Electric Tariff”).

Identification of Tariff Amendments:

Twelfth Revised Leaf No. 148
Third Revised Leaf No. 408.6
Second Revised Leaf No. 468

To P.S.C. No. 220 Electricity

Effective: February 1, 2020

Purpose of the Filing:

The proposed revisions to the Electric Tariff will enable customers that would otherwise be eligible satellites to receive credits under the following tariff provisions to also have such credits apply to the customer charges for the Company’s deliveries of New York Power Authority (“NYPA”) power under Service Classification (“SC”) Nos. 4 and 12, pursuant to specific provisions as described in the enclosed tariff leaves:

- Rule No. 29 (Community Distributed Generation (“CDG”)),
- Rule No. 36 (Net Metering for Solar Electric Generating Equipment, Public Service Law (“PSL”) § 66-j.),
- Rule No. 37 (Net Metering for Wind Electric Generating Equipment, PSL § 66-l, and
- Rule No. 40 (Value of Distributed Energy Resources)

Conclusion and Notice:

The Company is filing these revisions to the Electric Tariff to become effective on February 1, 2020. The Company believes a targeted communication plan will be far more effective than newspaper publications to bring the proposed amendments to the attention of stakeholders. The Company will communicate to existing CDG and RNM host customers currently interconnected, as well as those in the Company's interconnection queue, to inform them of the tariff revision. Further communication will be offered to both existing CDG and RNM projects and prospective project developers through an informational webinar hosted by the Company as well as through postings to the Company's distributed generation website. Notices to other publications and websites frequented by distributed generation developers will also be considered. Therefore, the Company requests a waiver of the newspaper publication requirements of PSL § 66-12 and 16 NYCRR 720.8.

Attachment 1 contains redlined tariff leaves showing where the revisions to the above leaves have occurred. Please advise the undersigned of any action taken regarding this filing.
