Case 16-M-0330 - Petition of CTIA - The Wireless Association to Initiate a Proceeding to Update and Clarify Wireless Pole Attachment Protections

Dear Secretary Burgess:

Enclosed are the following tariff leaves transmitted for filing by Niagara Mohawk Power Corporation d/b/a National Grid ("Company") in compliance with the order from the New York Public Service Commission ("Commission") issued March 14, 2019 in the above referenced proceeding (the "Order").

This filing is made in compliance with the Order, which directed the Company to file, within 90 days, tariff amendments and associated Short Form Environmental Assessment Forms, setting new rates for wireless pole attachments, consistent with the discussion in the Order to become effective on August 1, 2019. A further revised redline and clean version of the tariff leaves are attached. Attachment 1 contains redlined tariff leaves showing where the changes to the above leaves have occurred. Attachment 2 is the associated Short Form Environmental Assessment Forms. Attachment 3 contains the workpapers supporting the Wireless Attachment Rate Calculation.

To conform the tariff to the discussion in the Order, the Company added and revised definitions governing pole attachments. The Order also directed Niagara Mohawk to replace its existing flat rates for distributed antenna systems with the new rates and terms for wireless attachments. Consistent with the more detailed process for charging for wireless equipment, the Company is also adding clarifying language to the provisions governing accessory equipment associated with wireline attachments, to improve consistency in how wireline and wireless attachments are treated.

In addition, the Company is also using this opportunity to provide a periodic update of its Wireline Attachment Rate, found in Rule 35.1, as part of this filing. The associated workpapers are contained in Attachment

In accordance with Ordering Clause 5 of this order, the requirements of PSL §66 (12) (b), §92 (2) (a), and 16 NYCRR §720-8.1 concerning newspaper publication of the proposed tariff amendments have been waived.
