Dear Secretary Burgess:

The enclosed tariff leaves, issued by New York State Electric & Gas Corporation ("NYSEG") and Rochester Gas and Electric Corporation ("RG&E") (together the "Companies"), are being transmitted for filing in compliance and accordance with Appendix 7-H (electronic tariff filing system) of the New York State Public Service Commission's ("PSC" or "Commission") Codes, Rules and Regulations (16 NYCRR Appendix 7-H). Appendix A sets forth a list of the revised tariff leaves. The tariffs are filed to become effective on June 19, 2019.

**Overview**

The Companies are requesting delivery rate increases for each business.

Prepared written testimony and exhibits comprising the Companies direct case in support of these tariff revisions are being filed contemporaneously, under separate cover. The enclosed tariffs effectuate the changes associated with the Companies' direct case.
