The above Statements are being filed pursuant to the Company's tariffs, General Information Section 6 of P.S.C. No. 120 and General Information Section 3 of P.S.C. No. 121 for electric service. This filing removes the Village of Van Etten from the list of villages shown on the Tax Surcharge Percentage Statement that impose the 1% tax on utility revenues. NYSEG received notice that the Village dissolved and the Company should no longer be collecting this tax¹.

Please let this letter and the attached validated referendum serve as the Certificate of Dissolution for the Village of Van Etten to be filed with the Secretary of State. The Village of Van Etten's Referendum on Dissolution was held on December 11, 2017.

This Certificate represents the final results in favor of Village Dissolution by a vote of 103 to 76; as approved by a majority of the electors voting in the Village of Van Etten. A Dissolution Plan was prepared and adopted by the Village of Van Etten on April 30, 2018. As set forth in the Dissolution Plan, the Village of Van Etten will dissolve on December 31, 2018.
