RE: Case 19-G-0066, Interruptible Balancing Provisions

Dear Secretary Phillips:

Consolidated Edison Company of New York, Inc. is filing with the Public Service Commission (the "Commission") amendments to its Schedule for Gas Service, P.S.C. No. 9 - Gas (the "Gas Tariff"), applicable to its customers in the City of New York and the County of Westchester.

The tariff amendments are issued with an effective date of November 1, 2020. The specific Gas Tariff leaves being revised are identified in Appendix A.

## **Reason for Filing**

The Commission's Order Adopting Terms of Joint Proposal and Establishing Electric and Gas Rate Plan, issued and effective January 16, 2020, in Cases 19-E-0065 and 19-G-0066 (the "Order"), adopted the Joint Proposal ("JP") set forth in Attachment A to the Order. On January 29, 2020, the Company made its Rate Year 1 ("RY 1") compliance filing in accordance with the Order, with the exception of the Gas Tariff changes related to the Interruptible and Off-Peak Firm ("Interruptible") Balancing provisions, as described in Appendix 25 to the JP. In the RY 1 filing, the Company stated that it would make a separate compliance filing to reflect the changes to the Interruptible and Off-Peak Firm balancing provisions prior to November 1, 2020. Today, the Company is filing the tariff amendments related to those Interruptible balancing provisions in compliance with the Order.

## **Tariff Changes**

The Company made the following tariff changes to incorporate the Interruptible Balancing Provisions:

- Added a definition for the Interruptible Delivery Requirement as it relates to the Interruptible Monthly Balancing, under the Definitions Section of Service Classification ("SC") No. 9.
- Added definitions for the Surplus and Deficiency Imbalances for the Interruptible Citygate Balancing and the Monthly Cashouts related to the Interruptible Monthly Balancing Service, under the Definitions Section of SC No. 9.
- Added variable balancing charges applicable to SC No. 9 Interruptible Customers who elect the Interruptible Daily or Monthly Balancing Service, under the Rates Section of SC No. 9.
- Eliminated the Daily Surplus and Deficiency Imbalance Credits and Charges related to the Daily Balancing Service, under the Credits and Charges Section of SC No. 20.
- Eliminated the Minimum Delivery Charges related to the Monthly Balancing Service, under the Charges and Credits Section of SC No. 20.
- Added Interruptible City Gate Balancing Credits and Charges for the Monthly Balancing Service, under the Charges and Credits Section of SC No. 20.
- Added Daily Cashout Credits and Charges and revised the Monthly Cashout Credits and Charges related to the Interruptible Daily Balancing Service, under the Cashout Credits and Charges Section of SC No. 20.
- Revised the Monthly Cashout Credits and Charges related to the Interruptible Monthly Balancing Service, under the Cashout Credits and Charges Section of SC No. 20.
- Revised the Cashout Credits and Charges provision for an Aggregated Group of Firm, Interruptible and Off-Peak Firm Customers, under the Cashout Credits and Charges Section of SC No. 20.
- Added operational requirements for the Monthly Balancing Service and modified those for the Daily Balancing Service, under the Operational Matters Section of SC No. 20.

The Company also streamlined the tariff by eliminating the balancing provisions applicable to Interruptible and Off-Peak Firm Customers under SC No. 9 since the balancing provisions under SC 20 also apply to SC 9 Direct Customers.
