**RE: Case 20-E-0095 – Tariff Filing by Niagara Mohawk Power Corporation d/b/a National Grid to Modify its Electric Tariff Schedule, P.S.C. No. 220, to Clarify Language Regarding the Treatment of Multi-Unit Buildings in Community Distributed Generation Projects.**

Dear Secretary Phillips:

Niagara Mohawk Power Corporation d/b/a National Grid (the “Company”) submits the following revised P.S.C. No. 220 – Electricity Tariff (the “Electric Tariff”) leaf for filing in accordance with the requirements of the New York State Public Service Commission (the “Commission”):

**Identification of Tariff Amendments:**

Eleventh Revised Leaf No. 149

To P.S.C. No. 220 Electricity

Effective: July 1, 2020

The Company filed a tariff amendment on February 24, 2020 to clarify the language regarding the treatment of multi-unit buildings in Community Distributed Generation (“CDG”) projects. In that filing, the Company suggested minor edits to comply with the intent of the Commission’s determination of multi-unit buildings’ occupants participating in CDG projects in the *Order Establishing A Community Distributed Generation Program and Making Other Findings* in Case 15-E-0082.<sup>1</sup> The purpose of this filing is to further clarify the language around the definition of a “unit.”

The Company is filing this revision to the Electric Tariff to become effective on July 1, 2020. The Company believes a targeted communication plan will be far more effective than newspaper publications to bring the proposed amendments to the attention of stakeholders. The Company will communicate to existing CDG Host customers currently interconnected, as well as those in the Company’s interconnection queue, to inform them of the tariff revision. Therefore, the Company requests a waiver of the newspaper publication requirements of PSL § 66-12 and 16 NYCRR 720.8.
