**NATIONAL GRID: DLM COMMERCIAL SYSTEM RELIEF PROGRAM
AMENDED TARIFF LEAVES**

Dear Secretary Phillips:

On March 20, 2020 the Public Service Commission issued *Order Adopting Tariff Change* (“Order”) in the subject proceedings. Ordering Clause No. 1 of the Order directed Niagara Mohawk Power Corporation d/b/a National Grid (“National Grid” or the “Company”) to file a tariff revision in compliance with the Order to become effective on May 1, 2020 on not less than one day’s notice. Ordering Clause No. 2 of the Order waived newspaper publication. The tariff revision so ordered was in response to clarifying tariff language proposed by National Grid in draft tariff leaves included with the Company’s Dynamic Load Management (“DLM”) Programs Annual Report filed on November 15, 2019. The filed draft tariff leaves proposed to clarify the definition of Performance Factor in the Company’s Commercial System Relief Program (“CSRP”).

Due to an oversight by National Grid, this tariff filing deadline was missed. National Grid apologizes for this oversight and asks the Commission to accept this untimely filing so that customers will have the benefit of this tariff clarification. The amended tariff leaves attached hereto have an effective date of May 26, 2020. Both redlined and clean tariff leaves are enclosed.
